The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the IAEA's Member States and has the honour to draw their attention to the **Subregional Workshop on Civil Liability for Nuclear Damage for Latin American Countries** to be held in Montevideo, Uruguay, from **7 to 9 June 2017**.

The purpose of the workshop is to provide information on the existing international nuclear liability regime, in particular concerning the international instruments adopted under the auspices of the IAEA, including the Protocol to Amend the Vienna Convention on Civil Liability for Nuclear Damage and the Convention on Supplementary Compensation for Nuclear Damage. An additional purpose of the workshop is to advise on the development of national nuclear liability legislation so that it reflects the principles and norms of the international regime, and to provide a forum at which participants can exchange information on possible difficulties, concerns and issues that their respective countries may have with the existing regime.

The attached Prospectus provides further details of the workshop. An advance copy of the draft programme is also enclosed for participants' information.

The workshop will be held in English with simultaneous interpretation into Spanish.

The workshop is intended for legal experts and senior governmental officials from selected IAEA Member States. Member States are invited to nominate up to two participants for this workshop and are strongly encouraged to identify suitable women participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the workshop. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Such assistance may be offered upon specific request to up to two participants per country provided that, in the IAEA's view, the participant(s) on whose behalf assistance is requested will make an important contribution to the workshop. The application for financial support should be made at the time of nominating the participant(s) using the enclosed Grant Application Form.

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in meetings, workshops or training courses or for consultants. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.

La Secretaría del Organismo Internacional de Energía Atómica (OIEA) saluda a los Estados Miembros del OIEA y tiene el honor de señalar a su atención la próxima celebración del **Taller Subregional sobre Responsabilidad Civil por Daños Nucleares para Países Latinoamericanos**, que tendrá lugar en Montevideo (Uruguay) del **7 al 9 de junio de 2017**.

La finalidad del taller es ofrecer información sobre el régimen internacional de responsabilidad por daños nucleares vigente, en particular con respecto a los instrumentos internacionales aprobados bajo los auspicios del OIEA, entre otros el Protocolo de Enmienda de la Convención de Viena sobre Responsabilidad Civil por Daños Nucleares y la Convención sobre Indemnización Suplementaria por Daños Nucleares. Otra finalidad del taller es prestar asesoramiento en la elaboración de leyes nacionales sobre responsabilidad por daños nucleares que reflejen los principios y las normas del régimen internacional, así como servir de foro en el que los participantes puedan intercambiar información sobre las posibles dificultades, inquietudes y problemas que puedan tener sus respectivos países en relación con el régimen vigente.

En la reseña informativa adjunta se ofrecen más detalles sobre el taller. Se adjunta también una copia preliminar del proyecto de programa a título informativo para los participantes.

El taller se celebrará en inglés, con interpretación simultánea al español.

El taller está dirigido a expertos jurídicos y altos funcionarios gubernamentales de determinados Estados Miembros del OIEA. Se invita a los Estados Miembros a designar un máximo de dos participantes para este taller y se les alienta encarecidamente a seleccionar con ese fin a mujeres calificadas.

Por lo general, el OIEA no está en condiciones de sufragar los gastos de viaje ni de otra índole de los participantes en el taller. No obstante, dispone de fondos limitados para ayudar a cubrir los gastos de asistencia de determinados participantes. Esa ayuda puede ofrecerse, previa solicitud expresa, a uno o dos participantes por país siempre que, en opinión del OIEA, las personas para las que se solicita puedan hacer una contribución importante al taller. La solicitud de apoyo financiero debe presentarse en el momento de la designación de los participantes utilizando el formulario de solicitud de subvención adjunto.

Cabe señalar que el OIEA no paga ninguna indemnización por daños o pérdida de efectos personales. Tampoco proporciona seguro médico a los participantes en reuniones, talleres o cursos de capacitación, ni a los consultores. Por lo tanto, se recomienda que estas personas adopten las medidas necesarias para contratar por su cuenta un seguro privado. No obstante, el OIEA cubrirá mediante un seguro los accidentes y enfermedades claramente relacionados con los servicios prestados al OIEA.

## **Prospectus**

### **A. Introduction**

The workshop is being organized by the International Atomic Energy Agency (IAEA) with the support of experts from the International Expert Group on Nuclear Liability (INLEX).

INLEX, which consists of expert members from IAEA Member States with and without nuclear power plants, as well as from those that ship nuclear and other radioactive material and those that do not, serves three major functions, namely to: (a) create a forum of expertise to explore and advise on issues related to

nuclear liability; (b) enhance global adherence by nuclear and non-nuclear States to an effective nuclear liability regime; and (c) assist in the development and strengthening of the national nuclear liability legal frameworks in IAEA Member States to protect the public and the environment, as well as to enhance nuclear safety.

In the context of enhancing global adherence to the international nuclear liability instruments and the strengthening of national nuclear liability legal frameworks, the IAEA Secretariat carries out on a regular basis, with the support of INLEX members, certain outreach activities, which include, inter alia, workshops for interested Member States. The continuation of INLEX and its support for IAEA's outreach activities to facilitate the achievement of a global nuclear liability regime have been repeatedly encouraged by the IAEA General Conference.

## **B. Objectives**

The main purpose of this workshop is to provide information on the existing international nuclear liability regime, in particular the instruments adopted under the auspices of the IAEA, including the Protocol to Amend the Vienna Convention on Civil Liability for Nuclear Damage and the Convention on Supplementary Compensation for Nuclear Damage.

An additional purpose of the workshop is to advise on the development of national implementing legislation to reflect the principles and norms of the international nuclear liability regime. Also, it will enable a comparison of international civil liability regimes for activities causing environmental damage, as well as providing an opportunity to advise on the principles of nuclear liability during transport.

Finally, the workshop will provide a forum in which participants can exchange information on possible difficulties, concerns or legal and policy issues that their respective countries may have with the existing international nuclear liability regime.

## **C. Target Countries**

Selected IAEA Member States in the Latin America region.

## **D. Participation**

The workshop is open to up to **two** participants per invited country. Participants should be senior governmental officials, preferably with a specialization in the field of nuclear law and dealing with the international legal regime of civil liability for nuclear damage.

## **E. Language of Instruction**

The workshop will be conducted in English with simultaneous interpretation into Spanish.

## **F. Structure**

The workshop will encompass presentations from experts on the selected topics, case studies and an open discussion on the international nuclear liability regime.

## **G. Nomination Procedure**
